## 7-YEAR-OLD BOY FOUND IN SAUDI ARABIA BMI NOT PAID SALARY

Siti Nurjanah binti Aep Dading (50), Indonesian Migrant Worker (BMI) from Kampung Tarikolot RT04/RW03, Cinangsi Village, Cikalong Kulon District, Cianjur Regency, West Java felt lied to by her employer about salary while working in Saudi Arabia for 7 years.

This was expressed by Siti when she complained to the Branch Leadership Council (DPC) SBMI Cianjur a few months ago.

To SBMI Cianjur, Siti said that her employer in Saudi Arabia had sodomized a letter of agreement that must be signed by Siti stating that her salary had been paid. At that time her employer promised to transfer her salary when Siti had returned to Indonesia.

But in fact, Siti was lied to by her employer. Since Siti was repatriated to Indonesia on November 15, 2019, until now her salary has not been transferred.

Siti further said that in 2018, she was delivered by her employer to the Embassy of Riyadh on the grounds that the employer could not pay Siti's salary during her work for approximately 7 years. At that time, Siti said, her employer complained to the Riyadh Embassy officials named Mamat, Gugun, and Ibnu Malik.

Finally, Siti stayed in the shelter of the Embassy of Riyadh for 1 year and Siti was persuaded to come forward with a salary receipt letter delayed by her employer. The employer promised to pay all salaries after Siti arrived in Indonesia by transfer.

"In fact, since Siti was repatriated to Indonesia in mid-2019, the salary promised to be transferred by her employer has not been there. That is,

his employer has lied to Siti Nurjanah," said Chairman of DPC SBMI Cianjur, Ajat Sudrajat.

According to Ajat, on May 17, 2020 Siti Nurjanah complained to DPC SBMI Cianjur to ask for help fighting for her salary rights for 7 years that were not paid and there was an employer receivable that is borrowing gold which if cashed is worth about 7000 reals.

"Following up siti's complaint, on July 10, 2020, we from SBMI Cianjur have complained to the Ministry of Foreign Affairs (MoD) by visiting the Ministry of Foreign Affairs office in Jakarta to ask for proof of agreement letter regarding Siti Nurjanah's salary," said Ajat.

Kedatangan DPC SBMI Cianjur ke kantor Kemenlu, kata Ajat, diterima oleh salah satu pegawai Kemenlu bernama Maki. Kepada SBMI Cianjur, pegawai Kemenlu bernama Maki itu mengatakan akan mencari dulu bukti surat perjanjian perihal gaji Siti Nurjanah.

"Tapi hingga sebulan lebih, kami tidak mendapat kabar apa pun dari pihak Kemenlu terkait perkembangan penanganan kasus ini," ungkap Ajat.

Pada 27 Agustus 2020, lanjut Ajat, SBMI Cianjur kembali mendatangi kantor Kemenlu di Jakarta untuk menanyakan lagi perihal gaji Siti Nurjanah.

"Namun, jawaban pak Maki masih sama. Masih mau dicari dulu sama stafnya. Artinya pihak Kemenlu tidak ada niat untuk mencari dan menyelesaikan masalah Siti Nurjanah karena dalam tenggang waktu selama satu bulan lebih, tidak ada jawaban yang diharapkan," ungkap Ajat.

Terbaru, pada tanggal 23 November 2020, SBMI Cianjur kembali menghubungi Kemenlu melalui telepon. Lagi-lagi, pihak Kemenlu mengatakan belum menemukan surat perjanjian perihal gaji Siti Nurjanah.

SBMI Cianjur menilai Kemenlu RI kurang serius menangani persoalan ini sehingga persoalan gaji Siti Nurjanah belum juga bisa terselesaikan.

"Kemenlu RI harus secara serius menangani persoalan ini. Bukti surat perjanjian perihal gaji Siti Nurjanah harus segera ditemukan agar Siti bisa segera mendapatkan hak gajinya," harap Ajat.

Bersadarkan kronologi pengaduan kasus yang dicatat SBMI Cianjur, Siti Nurjanah diberangkatkan ke Arab Saudi oleh sponsor bernama H Didi (almarhum) melalui PT Alvindo Mas Buana di Jakarta pada tahun 2000. Siti bekerja kepada majikan bernama Abdullah Naif Otebi sebagai Pekerja Rumah Tangga (PRT).

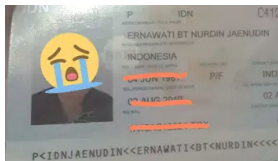
